## Harvest Specifications

<u>Comments</u>
Harvest Type = Clear-cut w/reserves

<u>Harvest and Reserves</u>
Harvest all Black Spruce. Reserve all Tamarack, Birch, Balsam Fir, Aspen, and Elm
Reserve all non-hazardous snags.

<u>Access</u>
Proposed access and landing are depicted on the map
Access is across Tax Forfeit land

<u>Landings and Access Roads</u>
Trails and landings need to be rehabilitated to a satisfactory condition before performance bond is returned.
Roads and landings must be approved by sale administrator.
Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

<u>Cutting, Felling, and Skidding</u>
Do not fell timber into wetlands or across sale boundaries.
Do not damage reserve trees.
Sale boundaries painted with orange slashes.

<u>Site, Soil, and Water Protection</u>
Roads and skid trails must be stablized. This may involve installing water bars, strike outs, and/or mulching and seeding.

<u>Slash Disposal</u>
Slash must be evenly distributed throughout permit area.

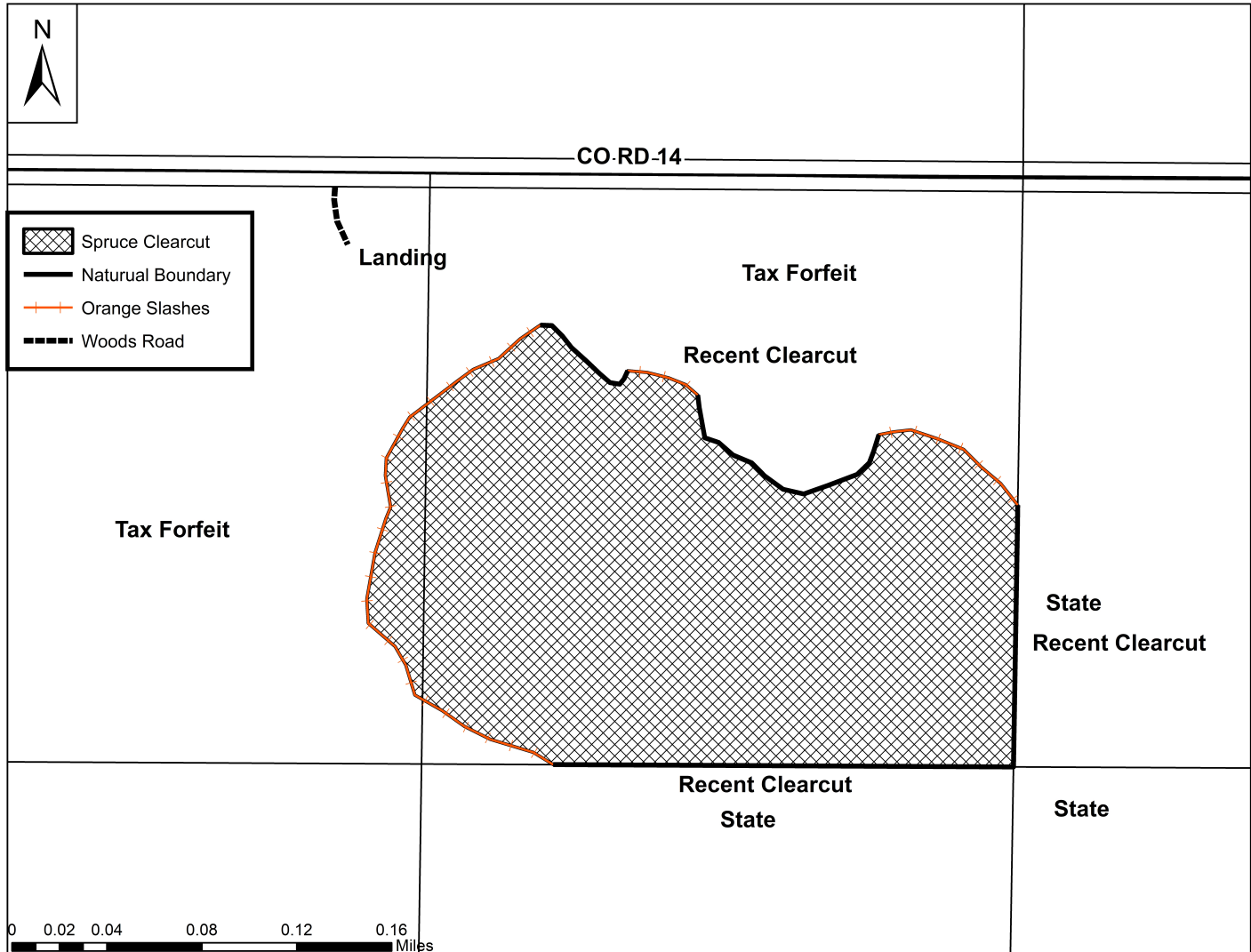
