#### **Landings and Access Roads**

Trails and landings need to be rehabilitated to a satisfactory condition, determined by administering forester, before performance bond is returned.

Temporary road approach must be constructed to access block on CR 72. Upon completion approach must be removed and ditch returned to original shape.

Roads and landings must be approved by sale administrator. Some existing roads through sale area must remain open as directed by sale administrator.

#### Cutting, Felling, and Skidding

Clearcut all stems within painted boundary except reserve species. Do not damage reserve trees.

Do not fell timber into wetlands or across sale boundaries.

Do not disturb survey markers, including witness trees. PIPE shown on sale map.

Sale boundaries painted Blue Slashes (III). Natural boundary against CR 72.

#### Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50' of all wetlands.

#### Slash Disposal

Slash must be evenly distributed throughout permit area. Slashed short ends and heavy slash must be backhauled and leveled out. Slash height must not exceed 3 ft. within view of road.

### **Special Conditions**

Logging season may be restricted to August through February during high bark beetle risk. All cut pine must be hauled within 3 weeks during June through August.

#### **Regeneration Plan**

Site will be replanted with Red Pine.


