HARVEST TYPE: 1ST TIME RED PINE THIN(49 ACRES), 1ST TIME WHITE SPRUCE THIN(36 ACRES), AND 2ND TIME RED PINE THIN(4 ACRES)

Harvest and Reserves

Blocks A, C, D & F are first entry pine thins; Cut 12' access strips reserving 40' between strips for thinning target 90 BA. Remove smaller, poor quality and overtopping trees first.

Block B is red pine second entry thin; use existing access strips and target 120 BA. Remove smaller and poor quality trees first.

Block E is first entry white spruce thin; Cut 12' access strips reserving 40' between strips for thinning target 90 BA. Remove smaller, poor quality and overtopping trees first.

Access

If harvested in winter Itasca County snowmobile regulations will apply.

State land must be crossed to access timber sale. Logger must obtain permission from land manager.

ATV trail uses access roads for this permit. Trail will need to be posted during active logging & trucking.

1 - 4.4 miles to Co. Rd. 348.

Landings and Access Roads

Berm(s) must be installed after sale is completed.

Cutting, Felling, and Skidding

Timber must be processed at the stump.

Do not damage "crop" trees.

Do not disturb survey markers, including witness trees.

Sale boundaries are painted in orange or are natural boundaries.

Block C: There is a 40-50' wetland between the west 2 blocks. To summer log the southwest block operator will need matting that must be removed when completed.

Block C: Cut all mature trees along the fringes of the red pine stands and the lowland types.

Block D: There are 2 - .5 acre patches to clear cut. One is on the north edge and one is on the east edge.

Blocks E and F: Aspen patches in both of these stands will be thinned with same requirements for first time thins.

Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50' of all wetlands.

Slash Disposal

A 10 ft. wide slash free zone must be maintained along roads and trails.

Slash height must not exceed 3 ft. within view of the Cameron Lake State Forest Road.

Special Conditions

Utilize all trees with at least 2 sticks up to a 3" top.

Logging season may be restricted to August through February during high bark beetle risk. All cut pine must be hauled within 3 weeks during June through August.

Loads with mixed species will be scaled as the highest value species, unless consumer scales species separately using county approved methods.


