## **Harvest and Reserves**

Clearcut all stems including ash > 7" DBH. Utilize all balsam fir 2 stick and greater.

Reserve cedar, white pine, all non-hazardous snags, den trees, and reserve trees marked with a blue "R".

#### Access

0.6 miles to West Bear Lake Forest Road. 0.3 miles of the Little Bear snowmobile trail will be used for access.

Snowmobile trail regulations in Itasca County Forest Management Guideline & Specifications apply. A minimum of two inches of compacted snow must remain on the trail as a running surface.

## **Landings and Access Roads**

Location and construction of any new roads/landings must be pre-approved by the sale administrator.

Trails and landings need to be rehabilitated to a satisfactory condition, determined by administering forester, before performance bond is returned.

## Cutting, Felling, and Skidding

Do not disturb survey marker or witness trees painted with an orange ring.

Harvest boundaries are painted with an orange dash or are natural.

Full tree/ whole tree skidding required in the jack pine block.

### Slash Disposal

Slash must be evenly distributed throughout permit area.

A 10 ft. wide slash free zone must be maintained along roads and trails.

## **Regeneration Plan**

Regeneration of jack pine and black spruce will be achieved by way of aerial seeding. Regeneration of lowland hardwoods and aspen will be achieved by natural seeding, stump sprouting and/or root suckering.


