Cut all tamarack, black spruce, aspen, and fir. Cut as much beetle killed tamarack as possible. Do not cut pine, oak, elm, maple, birch, or cedar.

Reserve all non-tamarack snags that are not hazardous.

Access

Northern route is 2.7 miles from County Road 72. Private land must be crossed to access timber sale. Logger must obtain permission from land owner. Southern route requires new road building and is 0.6 miles from Mutchler Road.

Landings and Access Roads

Location and construction of any new roads/landings must be pre-approved by the sale administrator.

Trails and landings need to be rehabilitated to a satisfactory condition, determined by administering forester, before performance bond is returned.

Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

Cutting, Felling, and Skidding

Do not fell timber across sale boundaries.

Harvest boundaries are natural or painted in orange paint (dashes).

Slash Disposal

Slash must be evenly distributed throughout permit area.

A 10 ft. wide slash free zone must be maintained along roads and trails.

Regeneration Plan

Natural regeneration and black spruce aerial seeding.


