Harvest and Reserves

Tamarack Block: Reserve healthy, full-crowned Tamarack seed trees every 70-80' where possible. Reserve all species other than Tamarack and any 'R' painted trees.

Aspen/Pine Block: Reserve White Pine, Spruce, Oak, Balsam less than 2 sticks, 'R' painted trees, and non-hazardous snags.

Landings and Access Roads

Trails and landings need to be rehabilitated to a satisfactory condition, determined by administering forester, before performance bond is returned.

Roads and landings must be approved by sale administrator.

2 Rock berms shown on map must be re-installed after sale is completed.

Cutting, Felling, and Skidding

Aspen/Pine Block: Timber must be processed at the stump due to minimal landing space.

Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50' of all wetlands.

Roads and skid trails must be stabilized. This may involve installing water bars, strike outs, and/or mulching and seeding.

Reserve all non-merchantable timber within 15ft of all wetlands.

Slash Disposal

Slash must be evenly distributed throughout permit area, and height must not exceed 3 ft. within view of road and trails. A 10 ft. wide slash free zone must be maintained along roads and trails.


