#### Access

Snowmobile trail regulations in Itasca County Forest Management Guideline & Specifications apply. A minimum of two inches of compacted snow must remain on the trail as a running surface.

Gates must remain locked during hunting season.

State land may be crossed to access timber sale. Logger must obtain permission from land manager.

0 - .6 miles to County Road 52 or 310.

Easement road must be used to access the timber sale. Access road must be kept in good condition, as determined by administering forester, at all times.

## **Landings and Access Roads**

Reserve all non-merchantable timber within 15ft of county roads.

Landings must be kept back at least 100' from Co. Rd 52 and 310.

## Cutting, Felling, and Skidding

Do not damage reserve trees.

Do not disturb survey markers, including witness trees.

Sale boundaries are painted in blue or are natural boundaries.

#### Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 60' of all wetlands.

Reserve all non-merchantable timber within 15ft of all wetlands.

#### Slash Disposal

Slash must be evenly distributed throughout permit area.

A 10 ft. wide slash free zone must be maintained along roads and trails.

Slash height must not exceed 3 ft. within view of Co. Rd. 52 and 310.


