Landings and Access Roads

Reserve all non-merchantable timber within 30 feet of County Road 52.

Location and construction of any new roads/landings must be pre-approved by the sale administrator.

Trails and landings need to be rehabilitated to a satisfactory condition, determined by administering forester, before performance bond is returned.

Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed. Landings must be kept back at least 100 feet from County Road 52.

Cutting, Felling, and Skidding

Do not fell timber into wetlands or across sale boundaries.

Painted property boundaries have 3 orange circles or 1 orange dash. Painted harvest boundaries have 3 orange dashes or 1 orange dash. Rest are natural boundaries.

Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50 feet of all wetlands.

Slash Disposal

A 10 foot wide slash free zone must be maintained along roads and trails.

Slash must be evenly distributed throughout permit area.

Regeneration Plan

Site will be hand planted to jack pine.


