Comments
Harvest Type: Tamarack/Black Spruce Clear-cut (22 acres).
Harvest and Reserves
Reserve all white pine, red pine & cedar.
Access
1.5 miles of existing road across USDA Forest Service and State land off of the Decker Lake Forest Road. Federal / State must be crossed to access timber sale. Logger must obtain permits/ permission from land owner/ land manager.
Landings and Access Roads
Location and construction of any new roads/landings must be pre-approved by the sale administrator. Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.
Cutting, Felling, and Skidding
Sale boundaries painted in orange/natural boundaries.
Slash Disposal
Slash must be evenly distributed throughout permit area.

Special Conditions

Utilize all trees with at least 2 sticks up to a 3" top.

All Black Spruce stems greater than 5ft. must be severed. Mistle Toe prevention. Moderate beetle damaged tamarack present in stand. Loads with mixed species will be scaled as the highest value species, unless consumer scales species separately using county approved methods.

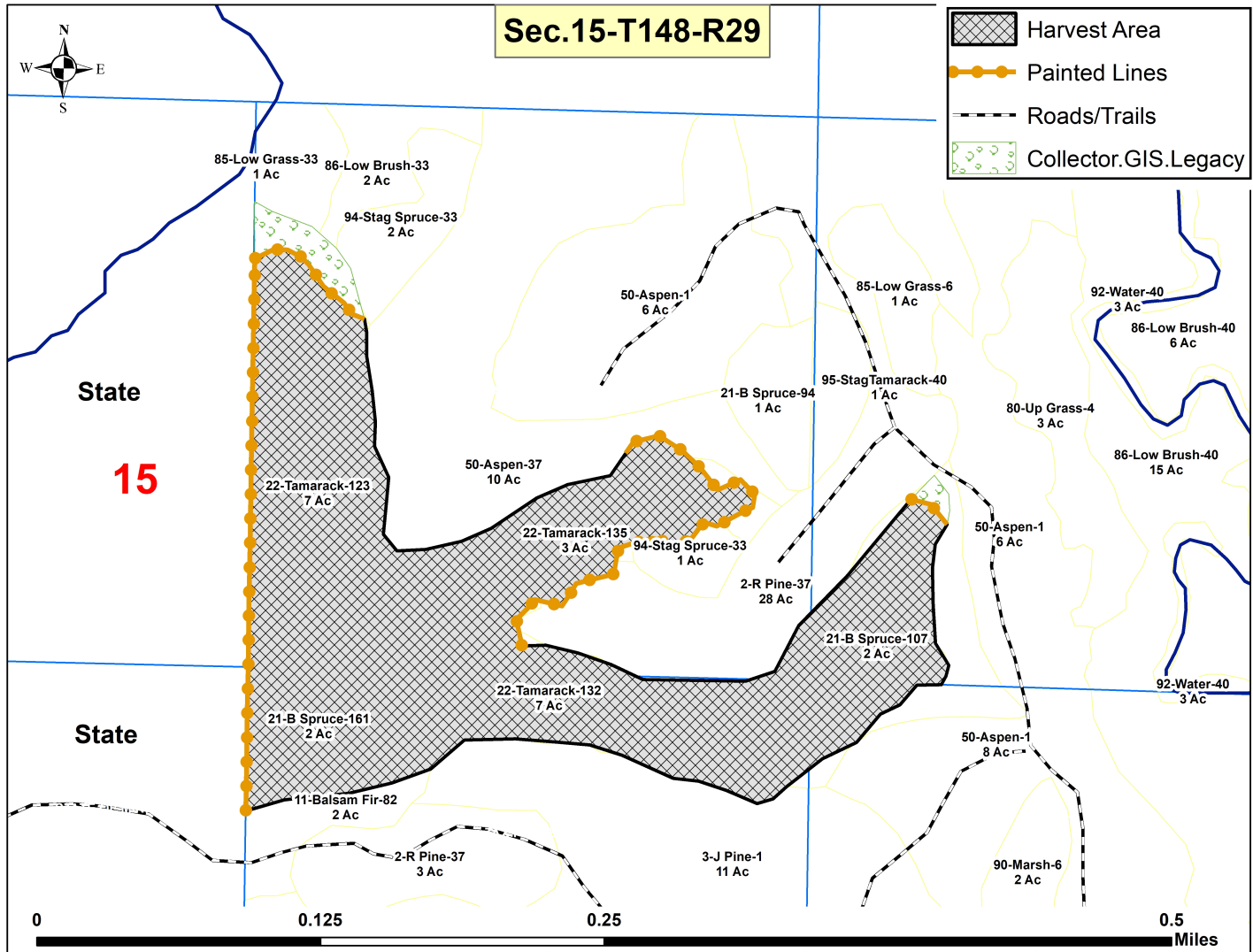
Regeneration Plan

Aerial Seed 1oz/acre Black Spruce. Expecting tamarack seed to blow in from adjacent stands and reserves along the sale edges.
