Cutting, Felling, and Skidding

Timber must be processed at the stump.

Cut 12 ft. access strips reserving 40 ft. in between strips for thinning. Thin stand down to an average of 90 basal area. Favor the removal of smaller diameter, poor quality, and damaged trees. Reserve aspen/balm along with all other species that are not overtopping w. spruce crop

Sale property boundaries are painted with 3 orange circles.

Do not fell timber into wetlands or across sale boundaries.

Do not damage reserve trees.

Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50' of all wetlands. Protect intermittent stream along access road into harvest block in the SENW sec. 10.

Regeneration Plan

Due to nature of managed species and type of harvest little to no tree regeneration is expected to occur after harvest.


